To: All Hon'ble Members of BGMEA

Honorable Members,

This is to inform you that '**PrimaDollar**'. a British Trade Finance company approached BGMEA. They offer a service for our exporters allowing them to work safely on sale contract without LC, giving the buyer credit if the buyer wants it, and still being able to obtain back-to-back in the local market.

As you know, our exporters are increasingly being asked by buyers to work on open account with deferred payment (without letter of credit, down-payment or guarantee). This means that it becomes difficult to get back-to-back financing and to meet the requirements of AD banks that foreign exchange must be received at or before shipment.

PrimaDollar's service pays the exporter in cash at sight; the buyer can pay later. The following steps are involved:

- Obtain a credit limit for a given buyer from PrimaDollar or from a participating local bank.
- Agree your purchase order(s) with the buyer.
- Exporters are paid at sight of shipping documents (up to the agreed limit).
- The buyer can pay later and PrimaDollar takes the buyer credit risk.

PrimaDollar's charges are low for this kind of service. Their online calculator is available on their website (<u>www.primadollar.com</u>); the calculator is simple and allows you to see the cost yourselves.

There are two ways to obtain this new service:

- From Agrani Bank Limited and First Security Islami Bank Limited (FSIBL). Other banks will soon start to offer similar facilities, and we will inform you; or
- From PrimaDollar directly at their office in Banani, Dhaka.

This service, as PrimaDollar has pointed out to us, is more than just a credit reference; PrimaDollar is paying cash upfront to you and takes the credit risk of the buyer. Please note that for large buyers with in-country inspection, PrimaDollar can support even firsttime trades. For smaller buyers, trading history is usually required.
